3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32369 is made and
4 entered, in duplicate, as of September 12, 2014 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 4, 2011, by and between RBF CONSULTING, a California corporation, with a
7 place of business at 14725 Alton Parkway, Irvine, California 92618 ("Consultant"), and
8 the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with As-Needed Transportation Engineering, Transportation
11 Planning, and Related Technical and Professional Services; and

12 WHEREAS, the parties entered Agreement No. 32369 whereby Consultant
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to extend the term of the Agreement;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 2 of Agreement No. 32369 is hereby amended to read as
18 follows:

19 "2. TERM. The term of this Agreement shall commence at midnight on
20 October 5, 2011, and shall terminate at 11:59 p.m. on October 4, 2015, unless sooner
21 terminated as provided in this Agreement, or unless the services or the Project is
22 completed sooner."

23 2. Except as expressly modified herein, all of the terms and conditions
24 contained in Agreement No. 32369 are ratified and confirmed and shall remain in full
25 force and effect.
