RESOLUTION NO. RES-20-0151

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH APPROVING AN INCREASE TO
THE DISCOUNT GAS RATE FOR QUALIFIED LOW-
INCOME GAS CUSTOMERS

WHEREAS, Chapter 15.36 of the Long Beach Municipal Code provides that the rates, services and conditions for natural gas provided by the City's gas utility shall be established by resolution of the Long Beach City Council; and

WHEREAS, the City has previously established a low-income gas discount program allowing certain qualified gas customers to apply for and receive a discount on their gas bill equal to approximately five percent (5%) of such bill; and

WHEREAS, other gas utilities operating in the Southern California area offer similar low-income gas discount programs, but with a higher discount rate; and

WHEREAS, the City Manager has submitted a proposed revision to the discount rate applicable to qualified applicants for consideration by the City Council;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. Effective for gas service billings generated on or after December 1, 2020, the low-income gas discount rate shall be equal to twenty percent (20%) and shall be applied in accordance with existing rules and regulations governing the City's low-income gas discount program. Except as specifically amended hereby, such program rules and regulations otherwise remain unchanged and are hereby affirmed.

Section 2. The City Manager is hereby authorized and directed to implement the low-income gas discount rate adopted on the effective date hereinabove set forth.
