3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35947 is made and
4 entered, in duplicate, as of May 25, 2022, for reference purposes only, pursuant to
5 Resolution No. RES-21-0048, adopted by the City Council of the City of Long Beach at its
6 meeting on May 18, 2021, by and between ZENCITY TECHNOLOGIES US INC., a
7 Delaware corporation ("Consultant"), with a place of business at 1313 N. Market Street,
8 Suite 5100, Wilmington, Delaware 19801, and the CITY OF LONG BEACH ("City"), a
9 municipal corporation.

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 35947 (the "Agreement") whereby Consultant agreed to provide an online civic
12 engagement platform; and

13 WHEREAS, the Parties desire to extend the term one (1) additional one-year
14 period;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 2 of the Agreement is hereby amended to read as follows:

18 "2. TERM. The term of this Agreement shall commence at midnight on
19 June 15, 2021, and shall terminate at 11:59 p.m. on June 14, 2023, unless sooner
20 terminated as provided in this Agreement, or unless the services or the Project is
21 completed sooner. The term may be renewed for one (1) additional one-year period, at
22 the discretion of the City Manager."

23 2. Except as expressly amended herein, all terms and conditions in
24 Contract No. 35947 are ratified and confirmed and shall remain in full force and effect.
