

1 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement
2 to add \$4,500 for the cloud backup subscription; and

3 WHEREAS, the Parties desire to extend the term one (1) additional one year
4 period, add force majeure language, amend the annual compensation, and attach a revised
5 price list;

6 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
7 conditions herein contained, the Parties agree as follows:

8 1. Section 13.09 of Agreement No. 30976 is hereby amended to read as
9 follows:

10 "13.09 The term of this Agreement shall commence at midnight on
11 December 18, 2008, and shall terminate at 11:59 p.m. on December 17, 2020, unless
12 sooner terminated as provided in this Agreement, or unless the services or the Project is
13 completed sooner. The term may be extended for one (1) additional one-year period, at
14 the discretion of the City Manager."

15 2. Consultant shall continue to provide Library Management System
16 services, and City shall pay for these services in the amount of One Hundred Forty-Nine
17 Thousand Seven Hundred Eighty Dollars (\$149,780) from December 18, 2019 to
18 December 17, 2020, and One Hundred Sixty-Two Thousand Three Hundred Sixty-Six
19 Dollars (\$162,366) from December 18, 2020 to December 18, 2021, at the rates or charges
20 shown in Exhibit "B-7".

21 3. Exhibit "B-6" attached to the Sixth Amendment to Agreement No.
22 30976 is hereby updated in accordance with Exhibit "B-7", attached hereto and
23 incorporated by this reference.

24 4. Section 14 is hereby added to Agreement No. 30976 to read as
25 follows:

26 "14. FORCE MAJEURE. If any party fails to perform its obligations
27 because of strikes, lockouts, labor disputes, embargoes, acts of God, inability to obtain
28 labor or materials or reasonable substitutes for labor materials, governmental restrictions,



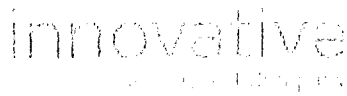
