3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 33933 is made and
4 entered, in duplicate, as of June 9, 2021 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on June 8, 2021,
6 by and between AETYPIC, INC., a California corporation, ("Consultant"), with a place of
7 business at 425 E. Fourth Street, Unit C, Long Beach, California 90802, and the CITY OF
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 33933 (the "Agreement") whereby Consultant agreed to provide as-needed architectural
11 services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 extend the term to July 19, 2018; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement
15 to extend the term to July 19, 2019; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement
17 to extend the term to July 19, 2020; and

18 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
19 to extend the term to July 19, 2021; and

20 WHEREAS, the Parties desire to extend the term one (1) additional one-year
21 period;

22 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
23 conditions herein contained, the Parties agree as follows:

24 1. Section 2 of the Agreement is hereby amended to read as follows:

25 "2. TERM. The term of this Agreement shall commence at midnight on
26 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2022, unless sooner terminated
27 as provided in this Agreement, or unless the services or the Project is completed sooner."

28 2. Except as expressly modified herein, all of the terms and conditions


