

ORDINANCE NO. C-7939

AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AMENDING THE LONG BEACH  
MUNICIPAL CODE BY ADDING DISTRICT N TO SECTION  
10.32.110 CREATING A NEW PREFERENTIAL PARKING  
DISTRICT

WHEREAS, after a duly noticed public hearing, the City Council  
determines and finds that more than sixty-six and two-thirds percent ( 66 $\frac{2}{3}$ %) of the  
properties on both sides of Greenbrier Road between the east-west alley located  
north of Anaheim Road and El Roble Street have indicated a positive desire for  
preferential parking privileges; and

WHEREAS, said area is zoned as a residential area; and

WHEREAS, there is currently a time restriction on parking in said area;

and

WHEREAS, the area meets the requirements for a preferential parking  
district pursuant to Long Beach Municipal Code Section 10.32.020; and

WHEREAS, Section 10.30.020 of the Long Beach Municipal Code  
allows the Traffic Engineer to use reasonable judgment regarding existing limited-time  
parking locations as to whether the criteria for preferential parking district would likely  
be met in the absence of the limited-time restriction; and

WHEREAS, the Traffic Engineer has determined that these criteria  
would be met on both sides of Greenbrier Road between the east-west alley located  
north of Anaheim Road and El Roble Street.

NOW, THEREFORE, the City Council of the City of Long Beach does

Section 1. Section 10.32.110 of the Long Beach Municipal Code is amended to add District N to read as follows:

District N: Greenbrier Road between the east-west alley located north of Anaheim Road and El Cedral Street, El Cedral Street between Greenbrier Road and Elmfield Avenue, El Roble Street between Greenbrier Road and El Prado Avenue, Los Flores Street between Greenbrier Road and El Prado Avenue, Vista Hermosa Street between Greenbrier Road and El Prado Avenue, and El Prado Avenue between Ramillo Avenue and the east-west alley located north of Anaheim Road.

Sec. 2. The City Clerk shall certify to the passage of this ordinance by the City Council of the City of Long Beach and cause the same to be posted in three conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.


