1 FIRST AMENDMENT TO AGREEMENT NO. 30826

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30826 is made and
4 entered, in duplicate, as of February 28, 2011, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 June 10, 2008, by and between DAVID EVANS AND ASSOCIATES, INC., an Oregon
7 corporation, with a place of business at 18004 Sky Park Circle, Suite 200, Irvine,
8 California 92614 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, the City and Consultant entered into Agreement No. 30826 for
11 the performance of specialized services in connection with As-Needed Transportation
12 Engineering, Transportation Planning, and Related Technical and Professional Services
13 in a not-to-exceed amount of \$500,000; and

14 WHEREAS, the parties desire to reduce the amount of the Agreement by
15 \$150,000;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions in
17 the Agreement and in this Amendment, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 30826 is amended in its entirety to
19 read as follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed \$350,000, at the
25 rates or charges shown in Exhibit "A".

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 30826 are ratified and confirmed and shall remain in full
28 force and effect.
