3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO PURCHASE UNLEADED AND DIESEL
6 FUEL THROUGH THE AGREEMENT BETWEEN CITY OF
7 GLENDORA AND MERRIMAC PETROLEUM, INC. DBA
8 MERRIMAC ENERGY GROUP

10 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
11 1802, permits the City to purchase services, supplies, materials, equipment and labor
12 with other government agencies by purchasing under their contracts on a voluntary and
13 selective basis when authorized by resolution; and

14 WHEREAS, the City desires to purchase unleaded and diesel fuel; and

15 WHEREAS, the City of Glendora has an agreement with Merrimac
16 Petroleum Inc. dba Merrimac Energy Group, identified by City of Glendora's requisition
17 number 00008013 ("Glendora - Merrimac Agreement"), for the purchase of unleaded and
18 diesel fuel through June 2017; and

19 WHEREAS, the City's participation in the Glendora - Merrimac Agreement
20 will facilitate acquisition of unleaded and diesel fuel as well as provide considerable cost
21 benefits to the City; and

22 WHEREAS, if the City had to go to formal bid rather than participate in the
23 Glendora - Merrimac Agreement considerably more funds would be required;

24 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
25 follows:

26 Section 1. The above recitals are true and correct and are incorporated
27 herein by this reference.

28 Section 2. The City Manager of the City is hereby authorized to enter an

1 agreement with Merrimac Petroleum, Inc. dba Merrimac Energy Group to purchase
2 unleaded and diesel fuel of substantially the same type and kind purchased by the City of
3 Glendora pursuant to the Glendora - Merrimac Agreement except as modified by mutual
4 agreement of the City and Merrimac Petroleum, Inc. dba Merrimac Energy Group, and
5 the purchase by the City shall be on the same terms and conditions afforded to the City
6 of Glendora in an amount not to exceed \$7,500,000 per year, including a recommended
7 25 percent contingency of \$1,500,000, if necessary, for two (2) years, with the option of
8 renewing for one (1) additional one-year period if funds are available.

9 Section 3. This resolution shall take effect immediately upon its adoption
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

11 I hereby certify that the foregoing resolution was adopted by the City
12 Council of the City of Long Beach at its meeting of November 18, 2014 by the
