THIS SECOND AMENDMENT TO AGREEMENT NO. 35829 is made and entered, in duplicate, as of May 27, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 17, 2020, by and between FIRST RATE STAFFING CORPORATION, a Delaware corporation ("Contractor"), with a place of business at 12150 S. Bloomfield Ave., Ste. B, Santa Fe Springs, California 90670, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to provide temporary shelter staffing services for human and social services programs in the Department of Health and Human Services; and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35829 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment increase the annual aggregate contract amount by \$1,000,000, for a one-year period and add a 20 percent contingency in the amount of \$200,000 for a revised total annual aggregate amount not to exceed \$2,700,000;

WHEREAS, the Parties desire to revise the budget;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

Exhibit "B" to Agreement 35829 is hereby amended and replaced with Exhibit "B-1", attached hereto and incorporated herein.

1. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35829 are ratified and confirmed and shall remain in full force and effect.
