SECOND AMENDMENT TO AGREEMENT NO. 34677

THIS SECOND AMENDMENT TO AGREEMENT NO. 34677 is made and entered, in duplicate, as of June 29, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 11, 2017, by and between BUREAU VERITAS NORTH AMERICA, INC., a Delaware corporation ("Consultant"), with a place of business at 180 Promenade Circle, Suite 150, Sacramento, California 95834, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34677 (the "Agreement") whereby Consultant agreed to provide as-needed plan review and inspection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 31, 2020; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 1, 2017, and shall terminate at 11:59 p.m. on July 31, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly amended herein, all terms and conditions in Agreement No. 34677 are ratified and confirmed and shall remain in full force and effect.
