TRANSIT LAW ENFORCEMENT SERVICES

This Contract Modification No. 4 to Contract No. PS95866000LBDP24750 effective January 1, 2022, by and between the LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY, hereinafter referred to as "METRO", and City of Long Beach through Long Beach Police Department (LBDP), hereinafter referred to as the "CONTRACTOR."

WHEREAS, Contractor and Metro entered into Contract No. PS5862300LBDP24750 (previous contract number), effective March 23, 2017, subsequently modified by Modification No. 1, effective January 8, 2018, Modification No. 2, effective October 1, 2019 and Modification No. 3 effective August 16, 2021 (the "Existing Contract") and;

WHEREAS, Contractor and METRO desire to amend the Existing Contract as provided herein;

Now, therefore, it is mutually agreed, by and between the parties as follows:

A. ARTICLE IV: COMPENSATION

The total Contract Price shall be increased by \$3,730,814 from \$33,222,590 to \$36,953,404 for a revised not-to-exceed Contract Price of \$36,953,404.


All other terms and conditions of Contract No. PS95866000LBDP24750 shall remain unchanged.

Except as expressly modified hereby, the Existing Contract, as modified remains in full force and effect as originally executed.




