

SECOND AMENDMENT TO AGREEMENT NO. 30933

THIS SECOND AMENDMENT TO AGREEMENT No. 30933 is made and entered, in duplicate, as of September 22, 2010 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on August 5, 2008, by and between ANCHOR ENVIRONMENTAL CA, L.P., a California 26300 La Alaneda, Suite 249 Hission vieto corporation, with a place of business at 28202 Cabet Road, Suite 425, Laguna Niguel; 92671 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with As-Needed Multi-Discipline Coastal Engineering and Environmental Consulting Services ("Project"); and

WHEREAS, City selected Consultant in accordance with City's administrative procedures and City has ascertained that Consultant and its employees are qualified, licensed, if so required, and experienced in performing such specialized services; and

WHEREAS, the parties entered into Agreement No. 30933 on October 17, 2008 for a term of one (1) year; and

WHEREAS, the parties exercised the first option to extend the term an additional year on December 18, 2009; and

WHEREAS, the parties now desire to extend the term for an additional vear:

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

- 1. Section 2 of Agreement No. 30933 is hereby deleted in its entirety and amended to read as follows:
- "2. TERM. The term of this Agreement shall commence on October 1, 2008, and shall terminate on September 30, 2011, unless sooner terminated



as provided in this Agreement, or unless the services or the Project is completed sooner."

Except as set forth in this Second Amendment to Agreement No.
 30933, all terms and conditions of the Agreement are ratified and confirmed and shall remain in full force and effect.
