

1 SECOND AMENDMENT TO AGREEMENT NO. 32819

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 32819 is made and
4 entered, in duplicate, as of April 4, 2014 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 August 7, 2012, by and between PERCEPTIVE ENTERPRISES, INC., a California
7 corporation ("Consultant"), with a place of business at 844 Colorado Blvd., Suite 204, Los
8 Angeles, California 90041, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed professional labor compliancy monitoring
12 services; and

13 WHEREAS, the parties entered Agreement No. 32819 whereby Consultant
14 agreed to provide such services; and

15 WHEREAS, the parties desire to extend the term and add \$100,000 for a
16 total not to exceed Contract amount of \$225,000;

17 NOW, THEREFORE, in consideration of the mutual terms and conditions in
18 the Agreement and in this Second Amendment, the parties agree as follows:

19 1. Section 1.A. of Agreement No. 32819 is hereby amended to read as
20 follows:

21 "1. SCOPE OF WORK OR SERVICES.

22 A. Consultant shall furnish specialized services more particularly
23 described in Exhibit "A", attached to this Agreement and incorporated by this
24 reference, in accordance with the standards of the profession, and City shall pay
25 for these services in the manner described below, not to exceed Two Hundred
26 Twenty-Five Thousand Dollars (\$225,000), at the rates or charges shown in
27 Exhibit "B".

28 2. Section 2 of Agreement No. 32819 is hereby amended to read as

1 follows:

2 "2. TERM. The term of this Agreement shall commence at midnight on
3 June 1, 2012, and shall terminate at 11:59 p.m. on May 31, 2015, unless sooner
4 terminated as provided in this Agreement, or unless the services or the Project is
5 completed sooner."

6 3. Except as expressly amended in this Second Amendment, all terms
7 and conditions in Agreement No. 32819 are ratified and confirmed and shall remain in full
8 force and effect.

9 IN WITNESS WHEREOF, the parties have caused this document to be duly
10 executed with all formalities required by law as of the date first stated above.
