RECOMMENDATION:

Receive the supporting documentation into the record, conclude the hearing and approve one of the following actions: 1) grant the permit with or without conditions; or 2) grant a One-Year Short-Term Permit with or without conditions; or 3) deny the permit on the application of The Green Mango, Inc., DBA Golden Villa Restaurant, 1360 E. Anaheim Street, #205, for Entertainment with Dancing by Patrons. (District 2)

DISCUSSION

The Long Beach Municipal Code (LBMC) requires an application be filed and a hearing be held before the City Council whenever this type of activity is requested and before an entertainment permit is granted or denied.

The LBMC also requires that the City Council make a determination that the permit application is complete and truthful; the applicant and the officers and trustees of the entity are law-abiding persons who will operate and conduct the business activity in a lawful manner; and that public peace, welfare and safety will not be impaired. If this is so, the application shall be approved, a short-term entertainment permit shall be approved, or the application shall be denied.

City departments have conducted their investigations in accordance with the LBMC. Attached for your review are the departmental investigative reports, the business ownership and permit history, and the entertainment permit application.

The following summarizes departmental findings:

 The Police Department recommends that the permit for entertainment with dancing by patrons be denied. Based on the Vice Section's investigation, opposition from local residents, and repeated violations from the owners of Golden Villa Restaurant, the Police Department has determined that the public peace, safety, and welfare of the general area would be impaired if this permit is granted. - The Fire Department finds that the building/location meets department requirements for the proposed use.
- The Health and Human Services Department finds that the building/location meets department requirements for the proposed use with the condition that the establishment remain in compliance with the Long Beach Noise Ordinance (LBMC Chapter 8.80).
- The Development Services Department finds that the building/location meets department requirements for the proposed use.

In the event that any of the recommended conditions are in conflict with other permits or licenses, the permittee shall adhere to the strictest of the applicable conditions. This location has been licensed as a restaurant since May 2003.

This matter was reviewed by Deputy City Attorney Cristyl Meyers on September 24. 2009.

TIMING CONSIDERATIONS

The hearing date of October 13, 2009, has been posted on the business location, with the applicant and property owners within 300 feet notified by mail.

FISCAL IMPACT

The following fees were collected with the application: Building Review \$20 and Zoning Review \$14 (Development Services Department), Police Investigation \$1,060 (Police Department), and Labels \$90 (Financial Management Department).

The following fees will be collected if the application is approved: Business License \$320.70 and Regulatory \$930 (Financial Management Department).



The Police Department recommends **DENIAL** of this application for Entertainment with Dancing, by the Green Mango Inc., dba the Golden Villa Restaurant, located at 1360 E. Anaheim Street #205. This recommendation is based on the owners' non-compliance with rules and regulations, and objections by residents living within 100 feet of the location.

Background

The Golden Villa is a restaurant that serves Asian food and is located on the southeast corner of Anaheim Street and Mahanna Avenue on the second floor of a small shopping center. The business is a for-profit corporation, The Green Mango Inc., dba Golden Villa Restaurant. The president is listed as Sophy Khut, who holds a type 41 (On Sale Beer and Wine Eating Place) ABC license. On May 20, 2008, the City Council approved a one-year short-term Entertainment with Dancing permit.

Crime Analysis

As part of the investigation, Vice Detectives examined calls for service, crime reports, and arrests at the above location for a two-year period between June 1, 2007 and June 1, 2009. The report indicated eleven calls for service, nine incident reports, and two arrests attributable to the business. Since approval of Golden Villa's last entertainment permit, there have been four calls for service, three incidents, and one arrest attributable to the business. The three incidents and one arrest resulted in the filling of three police reports and the issuance of one citation to the owner for violations of their entertainment permit. For further details, see crystal report analysis.

Resident Contacts

Vice Detectives also contacted residents living within 100 feet of the establishment. There were 31 residences within this distance. Nine residents were opposed to the addition of entertainment because of intoxicated patrons, lack of parking and loud late night music, especially when the back door of the business was left open. Previous conditions prohibited this door from being open during business hours, and prohibited patrons from exiting this rear door. Nine residents were not opposed to the addition of an entertainment permit. The remaining residents were not home during our investigation and were left a letter requesting they contact the Vice Investigations Section of the Long Beach Police Department.

Permit Violations

On May 20, 2008, the City Council approved Golden Villa for a one-year short-term Entertainment with Dancing permit. However, the hours of entertainment were restricted to 10:00 p.m. each night of the week. The conditions indicated that any entertainment offered beyond these hours shall be pre-approved by the Vice Investigations Section, no later than seven days prior to the scheduled event.

On June 24, 2009, the City Prosecutor's Office filed three counts of permit violations against Golden Villa. These violations occurred on February 26, 2009, March 6, 2009, and May 8, 2009. As a result of the citation issued to Golden Villa, Evan Braude, attorney for Golden Villa, spoke with Detective C. Anderson regarding the violations.

On May 20, 2009, the one-year short-term entertainment permit issued to Golden Villa expired. On June 1, 2009, Golden Villa applied for another entertainment permit. However, the business was not issued a temporary permit because of numerous permit violations.

On July 1, 2009, undercover Vice Detectives went to Golden Villa and determined ownership was providing entertainment without a valid permit. On July 2, 2009, Detective C. Anderson contacted Evan Braude, and advised him that Golden Villa was in violation of providing entertainment without a valid permit. On this same day, Evan Braude contacted the Business Relations Manager, Eric Sund, and attempted to obtain a temporary entertainment permit. Ownership was again told that no temporary permit would be issued for Golden Villa because of previous violations.

On July 8, 2009, undercover Vice Detectives went to Golden Villa and determined they were again providing entertainment without a valid permit.

On July 9, 2009, Detective C. Anderson met with the owners of Golden Villa, Sophy Khut and Kolvady Men, and Evan Braude. Detective C. Anderson discussed with ownership, the application for a new entertainment permit and the fact that they did not have a temporary permit to provide any entertainment. Ownership was advised that they would have to wait until their application went before City Council.

On July 15, 2009, undercover Vice Detectives went to Golden Villa and determined they were, once again, in violation of providing entertainment without a valid permit. Detectives also observed flyers on each table advertising, "Karaoke Nites." Golden Villa was cited for providing entertainment without a permit.

Patrol Division

South Division Patrol Commander Jay Johnson was contacted for an opinion regarding the issuance of this permit. He stated that over the past year there have been minimal calls for service to the location. He also indicated that gang members no longer congregate at this location. Commander J. Johnson has no objections to the proposed entertainment and does not believe the issuance of an entertainment permit will have an adverse impact on Patrol Division resources.

Vice Investigations

As part of the investigation, Vice Detectives went to the location in an undercover capacity on Wednesday, July 1, 2009, at approximately 2350 hours. There were approximately 25 patrons inside the location eating dinner. Several patrons were dancing to amplified music provided by a disc jockey. There were no security guards inside or outside of the business.

On Wednesday, July 8, 2009, at approximately 2115 hours, Vice Detectives went to the location. There were approximately 45 patrons inside the location eating, drinking, and dancing to music provided by a disc jockey. There were no security guards inside or outside of the business.

On Wednesday, July 15, 2009, at approximately 2205 hours, Vice Detectives went to the location. There were approximately 60 patrons inside the location eating, drinking and dancing to music provided by a disc jockey. There were no security guards inside or outside of the business.

Based on the above investigation, the permittee has a history of violating conditions of operation by providing entertainment beyond the approved hours and leaving the back door open during entertainment. Furthermore, the permittee has continued to violate the law by providing entertainment without a valid permit.

Recommendation

Based on the Vice Section's investigation, opposition from local residents, and repeated violations by the owners of Golden Villa, the Police Department has determined that the public peace, safety, and welfare of the general area would be impaired if this permit is granted. The Police Department recommends that the application for Entertainment Permit with Dancing by patrons, live amplified music, and karaoke be denied.

A review of the permit history for 1360 E. Anahelm Street, Unit 205, indicates that one Conditional Use Permit Exemption was approved for alcohol sales (Case No. 05-67), but no CUPs or AUPs were found for the subject property.

The subject property is located within the Community Commercial Pedestrian Oriented District (CCP). Within the CCP district, dancing by patrons is permitted as an accessory use for a restaurant. Based on the floor plans submitted for the previous application and the current application, there have been no significant changes made to the floor plan. No additional parking is required.

The Planning Bureau recommends that the entertainment permit with dancing for "Golden Villa Restaurant" be approved.
