3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 33580 is made and
4 entered, in duplicate, as of August 5, 2021, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on July
6 16, 2019, by and between SIMPLER SYSTEMS, INC., a California corporation
7 (“Consultant”), with a place of business at 1233 B State Street, Santa Barbara, California
8 93101, and the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.
10 33580 (the “Agreement”) whereby Consultant agreed to provide services in connection
11 with maintenance of the City’s Financial Accounting Information System; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement
13 to extend the term to September 30, 2017 and add the authorized annual amount of
14 \$150,000; and

15 WHEREAS, the Parties entered into a Second Amendment to the
16 Agreement to extend the term to September 18, 2018 and add the authorized annual
17 amount of \$150,000; and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement
19 to extend the term to September 30, 2020, add the authorized annual amount of
20 \$150,000, and update the City’s Notice address; and

21 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
22 to extend the term to September 30, 2021 and add the authorized annual amount of
23 \$150,000; and

24 WHEREAS, the Parties desire to extend the term one (1) additional one-
25 year period and add the authorized annual amount of \$150,000;

26 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
27 conditions herein contained, the Parties agree as follows:






