

1 FIRST AMENDMENT TO AGREEMENT NO. 33371

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33371 is made and  
4 entered, in duplicate, as of December 12, 2016 for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 February 23, 2016, by and between LONG BEACH PUBLIC TRANSPORTATION CO.  
7 ("LBT"), with a place of business at 193 E. Anaheim Street, Long Beach, California  
8 90801-0731, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and LBT entered into Agreement No. 33371 whereby LBT  
10 agreed to provide valid transit access to all eligible Belmont Shore employees on all  
11 established LBT bus service routes; and

12 WHEREAS, City and LBT desire to amend Agreement No. 33371 to extend  
13 the term for six months to provide sufficient time to optimize the Belmont Shore  
14 Employee Rider Pass Program elements;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
16 conditions herein contained, the parties agree as follows:

17 1. Section VI of Agreement No. 33371 is hereby amended to read as  
18 follows:

19 "VI. TERM & TERMINATION. Unless otherwise terminated, the term of  
20 this Agreement shall be between March 1, 2014 and September 1, 2016. Either party  
21 may terminate this Agreement by giving the other party written notice at least thirty (30)  
22 days prior to the termination date."

23 2. Except as expressly modified herein, all of the terms and conditions  
24 contained in Agreement No. 33371 are ratified and confirmed and shall remain in full  
25 force and effect.
