**DISCUSSION**



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING SECTION 2 OF RESOLUTION NO. RES-19-0129, KNOWN AS THE SALARY RESOLUTION OF THE CITY OF LONG BEACH, RELATING TO SALARY RANGE NUMBER 990 (CITY MANAGER); AND AMENDING SECTION 16 OF RES-19-0129 RELATING TO ELECTED OFFICIALS ANNUAL PAY ADJUSTMENT.

The City Council of the City of Long Beach resolves as follows;

Section 1. Section 2. Establishment of Offices, Positions and Compensation of Resolution No. RES-19-0129, as amended, is hereby amended by amending the rate for Salary Range Number 990 in the Salary Schedule (Attachment D) as follows:

Section 2. Section 16. Elected Officials Annual Pay Adjustment of Resolution No. RES-0129, shall be retitled to "Section 16. Elected Officials, City Manager and City Clerk Annual Pay Adjustment" and is amended to read as follows:

Effective July 1, 1995, and every July 1<sup>st</sup> thereafter, the annual salary ranges of all elected officials and the City Clerk will be adjusted in accordance with the provisions of Section 203 of the City Charter.

Effective July 1, 2021, and every July 1<sup>st</sup> thereafter, the annual salary range of the City Manager will be adjusted in accordance with the provisions of the Section 203 of the City Charter.

Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
