

1 FIRST AMENDMENT TO AGREEMENT NO. 29867

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29867 is made and
4 entered, in duplicate, as of February 20, 2009 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 May 23, 2006, by and between URS CORPORATION WHICH WILL DO BUSINESS IN
7 CALIFORNIA AS URS CORPORATION AMERICAS, a Nevada corporation
8 ("Consultant"), with a place of business at 915 Wilshire Boulevard, Suite 700, Los
9 Angeles, California 90017-3437, and the CITY OF LONG BEACH, a municipal
10 corporation ("City").

11 WHEREAS, the parties entered Agreement No. 29867 and Consultant
12 agreed to provide As-Needed Multi-Discipline Design Services ("Project"); and

13 WHEREAS, the parties desire to extend the term of the Agreement;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions in this Agreement, the parties agree as follows:

16 1. Section 2 of Agreement No. 29867 is hereby amended in its entirety
17 to read as follows:

18 "2. TERM. The initial term of this Agreement shall commence at midnight
19 on June 1, 2006, and shall terminate at 11:59 p.m. on May 31, 2009. The extended term
20 of this Agreement shall commence at midnight on June 1, 2009, and shall terminate at
21 11:59 p.m. on May 31, 2010, unless sooner terminated as provided in this Agreement, or
22 unless the services to be performed hereunder or the Project is completed sooner."

23 2. Except as expressly amended herein, all of the terms and conditions
24 in Agreement No. 29867 are ratified and confirmed and shall remain in full force and
25 effect.

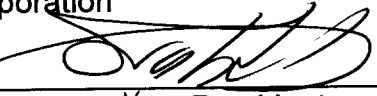

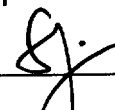
