FOURTH AMENDMENT TO AGREEMENT NO. 35246

THIS FOURTH AMENDMENT TO AGREEMENT NO. 35246 is made and entered, in duplicate, as of May 9, 2023, for reference purposes only, pursuant to minute orders adopted by the City Council of the City of Long Beach at its meetings on March 5, 2019 and November 17, 2020, by and between WILLDAN ENGINEERING, a California corporation ("Consultant"), with a place of business at 13191 Crossroads Parkway North, Suite 405, Industry, California 91746, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35246 (the "Agreement") whereby Consultant agreed to provide on-call environmental, planning and affordable housing consultant services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$300,000 for a total not to exceed amount of \$600,000 and extend the term to March 5, 2022; and

WHEREAS, the Parties entered into a Second Amendment to extend the term to March 5, 2023; and

WHEREAS, the Parties entered into a Third Amendment to extend the term one (1) additional one-year period and add \$105,000 to the Agreement for a total not to exceed amount of \$705,000; and

WHEREAS, the Parties desire to add \$260,000 to the Agreement for a total not to exceed amount of 965,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. 1.A. of the Agreement is hereby amended to read as follows:
 - "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in

1 the manner described below, not to exceed Nine Hundred Sixty-Five Thousand Dollars
2 (\$965,000), at the rates or charges shown in Exhibit "B".

3 2. Except as expressly modified herein, all of the terms and conditions
4 contained in Agreement No. 35246 are ratified and confirmed and shall remain in full force
5 and effect.
