I am requesting the following conditions for original ABC license for Carlos Abelardo Corterz and Oscar Javier Ramirez dba El Pollo Imperial, at 5991 Atlantic Ave:

1. No exterior advertising promoting or indicating the availability of alcoholic beverages
2. No sales to any person appearing to be or actually being intoxicated shall be allowed
3. Licensee shall take all reasonable measures to prohibit and prevent any loitering on the premises
4. Any graffiti on the premises shall be removed or painted over within 24 hours
5. All sales of alcohol shall be directly supervised by an authorized employee of the licensee, aged at least 21 years, including inspection of identification to verify age of purchaser, and observation of purchaser to ensure no sales to intoxicated persons
