1 FIRST AMENDMENT TO CONTRACT NO. 34730

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34730 is entered into, in
4 duplicate, effective as of October 17, 2018, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 July 18, 2017, by and between PERFORMANCE EXCELLENCE PARTNERS, LLC, a
7 Delaware limited liability company ("Contractor"), with offices located at 7911 Professional
8 Circle, Huntington Beach, California 92648, and the CITY OF LONG BEACH, a municipal
9 corporation ("City") and administering entity for Pacific Gateway Workforce Investment
10 Network.

11 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
12 34730 (the "Contract") whereby Contractor agreed to provide various workforce
13 development services to Pacific Gateway and its Board; and

14 WHEREAS, the Parties desire to add \$60,000 to the Contract for a total not
15 to exceed amount of \$250,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the Parties agree as follows:

18 1. Section 5.A of the Contract is hereby amended to read as follows:

19 "A. The total amount which shall be payable by City to Contractor
20 for Contractor's allowable services during the Term shall not exceed Two Hundred
21 Fifty Thousand Dollars (\$250,000)."

22 2. Except as expressly amended herein, all terms and conditions in
23 Contract No. 34730 are ratified and confirmed and shall remain in full force and effect.
