## FIRST AMENDMENT TO AGREEMENT NO. 28344

THIS FIRST AMENDMENT TO AGREEMENT NO. 28344 is made and entered, in duplicate, as of October 6, 2009 for reference purposes only, pursuant to Resolution No. C-28109 adopted by the City Council of the City of Long Beach at its meeting held on November 12, 2002, by and between WASTE MANAGEMENT COLLECTION AND RECYCLING, INC., a California corporation, doing business as WASTE MANAGEMENT OF SAN GABRIEL/POMONA VALLEY ("Contractor") located at 13940 East Live Oak Avenue, Baldwin Park, California 91706, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, Section 1802 of the Long Beach City Charter permits the City to enter contracts through the contracts of governmental agencies when authorized to do so by a resolution; and

WHEREAS, Resolution No. C-28109 authorized the City Manager to enter a contract with Contractor to obtain recycling services; and

WHEREAS, the parties entered Agreement No. 28344 whereby Contractor agreed to provide recycling services pursuant to Resolution No. C-28109; and

WHEREAS, the parties desire to extend the term of Agreement No. 28344;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein, the parties agree as follows:

- 1. Section 3 of Agreement No. 28344 is amended in its entirety to read as follows:
- "3. The initial term of this Agreement shall begin on January 1, 2003 and shall end on December 31, 2009. The extended term of this Agreement shall begin on January 1, 2010 and shall end on December 31, 2012. This Agreement may be terminated as stated in the Pasadena Contract."
- 2. Except as expressly amended in this First Amendment, all terms and conditions in Agreement No. 28344 are ratified and confirmed and shall remain in full
