ORDINANCE NO. ORD-05-0025

3 AN ORDINANCE OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AMENDING THE LONG BEACH  
5 MUNICIPAL CODE BY AMENDING SECTIONS 10.24.076,  
6 10.24.077, 10.24.078, AND 10.24.079, AND ADDING  
7 SECTIONS 10.24.005 AND 10.24.080, RELATING TO  
8 PARKING OF OVERSIZED VEHICLES  
9

10 WHEREAS, the parking of oversized vehicles can have a negative effect  
11 on traffic safety by obscuring clear views of other traffic, pedestrians, and traffic signs  
12 and signals, as well as obstructing driving lanes; and

13 WHEREAS, the parking of oversized vehicles in residential areas can  
14 create safety hazards for drivers and pedestrians, and consumes needed on-street  
15 parking, especially in areas of the City where streets are narrow or where a shortage of  
16 off-street vehicle parking exists; and

17 WHEREAS, the parking of oversized vehicles on non-residential public  
18 streets can obstruct business and informational signs, to the detriment of the  
19 businesses in the community.  
20

21 NOW, THEREFORE, the City Council of the City of Long Beach does  
22 hereby ordain as follows:  
23

24 Section 1. Section 10.24.076 of the Long Beach Municipal Code is  
25 amended in its entirety to read as follows:

26 10.24.076 Continuation of existing oversized vehicle regulation.

27 Except as otherwise provided in this Chapter, and except as  
28 amended or altered from time to time under the authority of this Chapter,

1 all oversized vehicle restrictions and prohibitions heretofore placed in the  
2 City shall remain in full force and effect. The elimination from this Code of  
3 previously-enumerated locations for such regulation does not constitute  
4 the repeal of such regulations.

5  
6 Sec. 2. Section 10.24.077 of the Long Beach Municipal Code is amended  
7 in its entirety to read as follows:

8 10.24.077 Posting of restrictions.

9 The City Traffic Engineer shall place and maintain or cause to be  
10 placed and maintained, on each of the streets or portions of streets on  
11 which oversized vehicle parking is restricted, appropriate signs notifying  
12 the public of such restrictions.

13  
14 Sec. 3. Section 10.24.078 of the Long Beach Municipal Code is amended  
15 in its entirety to read as follows:

16 10.24.078 Parking of oversized vehicles prohibited.

17 A. Where posted, no person who owns, has custody, or control of  
18 an oversized vehicle as defined in Section 10.24.005, shall cause it to be  
19 parked on any public street.

20 B. Subsection (A) shall not apply to an oversized vehicle, so long  
21 as it is parked in a manner which otherwise complies with applicable state  
22 law and the City of Long Beach Municipal Code, when a valid permit is  
23 displayed on the inside of the lower left corner of the windshield of an  
24 oversized vehicle so as to be visible from the street. Said permit may be  
25 obtained and displayed in accordance with section 10.24.080 of this  
26 Chapter.

27 C. Subsection (A) shall not apply to a commercial vehicle which is  
28 engaged in the active loading or unloading of goods for a period of time which

1 does not exceed the permitted commercial loading period as defined in  
2 10.24.005.

3  
4 Sec. 4. Section 10.24.079 of the Long Beach Municipal Code is amended  
5 in its entirety to read as follows:

6 10.24.079 Designation and termination of oversized vehicle parking restrictions.

7 Installation or removal of oversized vehicle parking restrictions may  
8 be initiated by the City Traffic Engineer or by petition. Eligibility for  
9 oversized vehicle restrictions shall be determined by the City Traffic  
10 Engineer, after consideration of street size, traffic patterns and volume,  
11 traffic on nearby streets or street segments, neighborhood characteristics,  
12 and Citywide traffic plans.

13 A. For installation or removal of oversized vehicle restrictions by  
14 petition on a residential street, the City Traffic Engineer shall provide a  
15 petition form containing the street addresses of properties with front curbs  
16 proposed to be affected by the action. In order to be deemed sufficient, a  
17 petition for a residential street must contain the signatures of residents of  
18 residential units at two-thirds (2/3) of the addresses listed.

19 B. The City Traffic Engineer shall make available to members of  
20 the public a petition form by which property owners or owner's agents may  
21 petition for the installation or removal of oversized vehicle restrictions on a  
22 non-residential street. The petition form shall contain the street  
23 addresses of properties proposed to be affected by the action. In order to  
24 be deemed sufficient, a petition for a non-residential street must contain  
25 the signatures of owners or owner's agents for at least two-thirds (2/3) of  
26 the linear street frontage described on the petition, irrespective of the  
27 property's legal address.

1                   Sec. 5. Section 10.24.005 is added to the Long Beach Municipal Code to  
2 read as follows:

3                   10.24.005 Definitions.

4                   The following definitions shall apply to this Chapter:

5                   A. "Oversized vehicle" means a vehicle which exceeds eighty-five  
6 inches (85") high or eighty inches (80") wide or twenty feet (20') long on a  
7 residential street or eighty-five inches (85") high or twenty feet (20') long  
8 on a non-residential street. A boat, equipment or other object on or  
9 attached to a trailer shall be measured together with the trailer.

10                  B. "Non-residential street" means a street or portion thereof on  
11 which the majority of traffic is non-residential, and which is adjacent to  
12 property on which the majority of uses are commercial, industrial or  
13 institutional.

14                  C. "Residential street" means a street or portion thereof adjacent  
15 to property on which the majority of uses are residential in nature.

16                  D. "Permitted commercial loading period" means the time allowed for the  
17 actual loading or unloading of goods. The permitted commercial loading period  
18 shall be twenty minutes, or such other time period as posted by the city traffic  
19 engineer.

20  
21                  Sec. 6. Section 10.24.080 of the Long Beach Municipal Code is added to read  
22 as follows:

23                  10.24.080 Oversized vehicle forty-eight (48) hour parking permit for  
24 residential streets.

25                  A. The fire department, or such other department as the city  
26 manager shall designate, is authorized to issue oversized vehicle parking  
27 permits for campers, trailers, boats on trailers, and recreational vehicles  
28 for the purpose of such activities as loading, unloading or performing

1 maintenance on such vehicles for a period of not more than forty-eight  
2 (48) hours. Such activities must be conducted in compliance with all other  
3 laws and regulations. No more than twelve (12) permits shall be issued to  
4 any one eligible resident or to any one eligible vehicle within one calendar  
5 year and a twenty-four hour period must elapse between permits.

6 B. Oversized vehicle parking permits shall be issued for eligible  
7 vehicles upon application of the registered owner or such other person  
8 who can provide evidence of residency at a location at which on-street  
9 parking of oversized vehicles is prohibited and can demonstrate exclusive  
10 use and control of the vehicle for which application is made.

11 C. Each oversized vehicle parking permit shall be issued for a  
12 period not to exceed forty-eight (48) hours in duration. Each application  
13 or re-application for oversized vehicle parking permits shall be in writing  
14 and shall contain sufficient information to satisfy the administering  
15 department as to the identity and residential address of the applicant, the  
16 applicant's registered ownership or exclusive use and control of the  
17 vehicle for which application is made, the license number of the vehicle,  
18 and any other information that the administering department deems  
19 necessary for the proper processing of the application.

20 D. The Fire Chief or his designee may place further restrictions on  
21 any permit issued as deemed necessary to protect the public health and  
22 safety. Such restrictions shall appear on the face of the permit which shall  
23 be displayed on the inside of the windshield of the vehicle for which the  
24 permit is issued so as to be readily visible to a person approaching the  
25 vehicle from the front thereof.

26 E. Applications for issuance of forty-eight (48) hour permits shall  
27 be accompanied by such fee therefor as may be established from time to  
28 time by resolution of the City Council,




