ORDINANCE NO. ORD-15-0031

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY ADDING SECTION 18.48.195,
RELATING TO TESTING AND OPERATION

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 18.48.195 is added to the Long Beach Municipal
Code to read as follows:

18.48.195 CFC Chapter 1, Section 107.2 - Testing and operation.

Section 107.2 of Chapter 1 of the California Fire Code is amended by
the addition of Section 107.2.3 to read:

107.2.3 Submission of records. Contractors, engineers, test
companies and licensed and/or certified testers who perform inspection,
testing and/or maintenance services on fire protection and life safety
systems and equipment within the City of Long Beach are required to
electronically submit all compliant and non-compliant reports to the Long
Beach Fire Department via a method approved by the fire code official.

Section 2. The City Clerk shall certify to the passage of this ordinance by
the City Council and cause it to be posted in three (3) conspicuous places in the City of
Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the
Mayor.


