## FIRST AMENDMENT TO CONTRACT NO. 30252

THIS FIRST AMENDMENT TO CONTRACT NO. 30252 is made and entered, in duplicate, as of February 6, 2008 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on April 4, 2006, by and between COMPREHENSIVE CHILD DEVELOPMENT, INC., a nonprofit California corporation, with offices located at 2545 Pacific Avenue, Long Beach, California 90806 ("Organization"), and the CITY OF LONG BEACH, a municipal corporation (the "City").

WHEREAS, the City has received a grant from the U.S. Department of Housing and Urban Development ("HUD") for a program called "Continuum of Care Homeless Assistance" which deals with the needs of the homeless; and

WHEREAS, Organization provides transitional housing, permanent housing, human or social services to low-income and homeless residents; and

WHEREAS, as part of the 2006 Supportive Housing Grant Agreement ("Grant Agreement") the City is required to enter into subcontracts with organizations that provide housing and supportive services to the homeless and the City has selected Organization as a sub-recipient of grant funds; and

WHEREAS, the City Council has authorized the City Manager to enter into a contract with Organization that provides the grant funding within a maximum amount and program accountability by the City; and

WHEREAS, the parties desire to extend the term of the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the parties agree as follows:

1. Section 3 of Contract No. 30252 is amended in its entirety to read as follows:

"Section 3. The term of this Contract shall commence at midnight on April 4, 2006, and, unless sooner terminated as provided herein shall terminate at 11:59 p.m.
