EPA Awards San Pedro Bay Ports

 USEPA awarded \$6 million in Stimulus Grant funding to POLB and POLA at its regional press conference on October 1, 2009.

Technology Advancement Program

- On October 19, 2009 the Port of Long Beach BHC approved funding to demonstrate an emulsified biodiesel fuel project in cargo-handling equipment.
- The biodiesel fuel will be demonstrated on three top handlers at Ports America (Port of Los Angeles).

Clean Trucks Program

- · Clean Trucks Program
 - First year a success!
 - Approximately 6,600 trucks in the DTR that meet 2007 emission standards for both ports.
 - Over 65% of truck trips are considered "clean" for both ports.
 - Percentage of trips by Natural Gas trucks continues to increase.

VSR Programs

- POLB's 20 nm and 40 nm boundary in the Green Flag Incentive Program compliance rates are 96% and 75%, respectively, as of November 2009
- POLB's BHC approved an extension of the Green Flag Incentive Program through 2010
- POLA's 20 nm and 40 nm boundary in the Green Flag Incentive Program compliance rates are 90% and 50%, respectively, as of November 2009

- POLB's 2008 Air Emissions Inventory was released 12/21/09.
- POLB's emissions were reduced by 21% for DPM, 12% for NOx, 18% for SOx, and 7% for CO2 equivalent.
- POLA's 2008 Air Emissions Inventory was released 11/5/09.
- POLA's emissions were reduced by 19% for DPM, 9% for NOx, 32% for SOx, and 4% for CO2 equivalent.
