THIS FIRST AMENDMENT TO PERMIT NOT 35023 is made and entered, in duplicate, as of October 9, 2018 for reference purposes only, pursuant to authorization by the PARKS AND RECREATION COMMISSION OF THE CITY OF LONG BEACH, through the Director of the Department of Parks, Recreation and Marine (“Director”) of the City of Long Beach (“City”) at its meeting on September 20, 2018, and IN CIRCUS ENTERTAINMENT, LLC, a California limited liability company (“Permittee”), with offices located at 2698 Junipero Avenue, Suite #117, Signal Hill, California 90755.

WHEREAS, Railway Concession Permit No. 35023 was issued to Permittee for the operation of an 18-gauge model train in El Dorado East Regional Park, Area III (“El Dorado”); and

WHEREAS, the Parties hereby desire to amend Permit No. 35023 to add certain picnic sites to the Permit Area;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Permit No. 35023, the parties agree as follows:

1. The Permit Area attached as Exhibit “A” to Permit No. 35023 is hereby amended and replaced with Exhibit “A-1,” attached hereto and incorporated herein by this reference

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. 35023 are ratified and confirmed and shall remain in full force and effect.






