

1 SIXTH AMENDMENT TO AGREEMENT NO. 34132

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 34132 is made and  
4 entered, in duplicate, as of October 8, 2018, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 October 20, 2015, by and between JOVENVILLE, LLC DBA WE THE CREATIVE, a  
7 California limited liability company ("Consultant"), with a place of business at 2810 Villa  
8 Way, Newport Beach, California 92663, and the CITY OF LONG BEACH, a municipal  
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be  
11 performed in connection with as-needed graphic design and creative services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
13 34132 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
15 add \$28,500 for a total not to exceed amount of \$38,500; and

16 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
17 to add \$57,400 for a total not to exceed amount of \$95,900; and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
19 to add \$35,000 for a total not to exceed amount of \$130,900; and

20 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement  
21 to add \$47,576 for a total not to exceed amount of \$178,476; and

22 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to  
23 extend the term to November 30, 2018 and add \$215,000 for a total not to exceed amount  
24 of \$393,476; and

25 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
26 period and add \$330,000 for a total not to exceed amount of \$723,476;

27 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
28 conditions herein contained, the Parties agree as follows:

1           1.     Section 1.A. of the Agreement is hereby amended to read as follows:

2                     “A.    Consultant shall furnish specialized services more particularly  
3                     described in Exhibit “A”, attached to this Agreement and incorporated by this  
4                     reference, in accordance with the standards of the profession, and City shall pay for  
5                     these services in the manner described below, not to exceed Seven Hundred  
6                     Twenty-Three Thousand Four Hundred Seventy-Six Dollars (\$723,476), at the rates  
7                     or charges shown in Exhibit “B”.”

8           2.     Section 2 of the Agreement is hereby amended to read as follows:

9                     “2.    TERM.   The term of this Agreement shall commence at midnight on  
10                     December 1, 2015, and shall terminate at 11:59 p.m. on November 30, 2019, unless  
11                     sooner terminated as provided in this Agreement, or unless the services or the Project is  
12                     completed sooner.”

13           3.     Except as expressly modified herein, all of the terms and conditions  
14                     contained in Agreement No. 34132 are ratified and confirmed and shall remain in full force  
15                     and effect.




