1 FIRST AMENDMENT TO CONTRACT NO. 32961

3 THIS FIRST AMENDMENT TO CONTRACT NO. 32961 is made and
4 entered, in duplicate, as of June 15, 2014 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 February 12, 2013, by and between ARB, INC., a California corporation ("Contractor"),
7 whose address is 26000 Commercentre Drive, Lake Forest, California 92630, and the
8 CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, pursuant to a "Notice Inviting Bids for the Remediation and
10 Relocation of Natural Gas Pipelines and Facilities for 2013 in the City of Long Beach,
11 California," dated November 20, 2012, and published by City, bids were received, publicly
12 opened and declared on the date specified in said Notice; and

13 WHEREAS, the parties entered into Contract No. 32961 (the "Contract") for
14 the work described in the bid documents; and

15 WHEREAS, the parties desire to extend the term of the Contract without
16 increasing the authorized amount thereunder;

17 NOW, THEREFORE, in consideration of the terms and conditions
18 contained herein, the parties agree as follows:

19 1. Section 4 of Contract No. 32961 is hereby amended to read as
20 follows:

21 "4. TIME FOR CONTRACT. Contractor shall commence work on a date
22 to be specified in a written "Notice to Proceed" from City and shall complete all work prior
23 to March 31, 2015, subject to strikes, lockouts and events beyond the control of
24 Contractor. Time is of the essence hereunder. City will suffer damage if the work is not
25 completed within the time stated, but those damages would be difficult or impractical to
26 determine. So, Contractor shall pay to City, as liquidated damages, the amount stated in
27 the Contract Documents."




