THIS CONTRACT is made and entered, in duplicate, as of May 22, 2008 for reference purposes only, pursuant to Resolution No. RES-08-0055, adopted by the City Council of the City of Long Beach at its meeting on May 13, 2008, by and between HAAKER EQUIPMENT COMPANY ("Contractor"), a California corporation, located at 2070 N. White Avenue, La Verne, California 91750 and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City did by Resolution No. RES-08-0055 determine that the City's need to purchase Elgin Pelican street sweeper parts could only be met by Contractor and, by reason of the foregoing, no useful purpose would be served by advertising for bids to purchase such street sweeper parts;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

- 1. Contractor shall sell, furnish and deliver to City Elgin Pelican street sweeper parts as authorized by Resolution No. RES-08-0055.
- City shall pay Contractor in due course of payments for the street 2. sweeper parts a sum not to exceed \$300,000, including tax.
- 3. The term of this Contract shall commence at midnight on May 15, 2008, and shall terminate on May 15, 2009, with the option to renew for two additional one-year periods, at the discretion of the City Manager.
- 4. Neither this Contract nor any of the moneys that may become due Contractor hereunder may be assigned without the prior written consent of City.
- 5. Any notices required hereunder or desired to be given by either party shall be in writing and personally delivered or deposited in the U.S. Postal Service, first class postage prepaid, addressed to Contractor at the address stated herein, and to City at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager. Notice shall be deemed given on the date personal delivery is made or on the date of deposit in

the mail, whichever first occurs.

6. City shall have the benefit of any warranty from the manufacturer on the Elgin Pelican street sweeper parts supplied and Contractor warrants that the street sweeper parts are in good working order and free from defect at the time of delivery.
