ASSIGNMENT CONSENT AGREEMENT

RECITALS. This Assignment Consent Agreement is made with reference to the following facts and objectives:

A. On September 6, 1962 the City and Alamitos Land Company, as lessors and J. A. Campbell and H. H. Herder, a copartnership, and J. A. Campbell, an individual, collectively doing business as Herbell Oil Exploration Co., as lessee, entered into that certain Recreation Park Oil and Gas Lease (the "Lease"), which Lease has been amended at various times.

- B. Assignor is the successor in interest to a portion of the interest of the original Lessee, Herbell Oil Exploration Co.
- C. Assignor desires to assign all of its right, title and interest in said Lease to Assignee and Assignee desires to accept same.
- D. City is willing to consent to the assignment on the terms and conditions of the Consent to Assignment set forth herein to which both Assignor and Assignee agree.

NOW THEREFORE, the parties hereto agree as follows:

- 3. Assignor agrees to remain bound to and guarantees fully the performance by Assignee of all of the terms, covenants and conditions of the Agreement for the remaining term thereof, notwithstanding anything to the contrary in any agreements between Assignor and Assignee.
- 4. Assignee accepts all of the rights, title, interest and obligations in and to the Agreement and agrees and covenants to incur and be responsible for all of the duties and obligations of Assignor thereunder, notwithstanding anything to the contrary in any other agreements between Assignor and Assignee.
- 5. This Assignment shall be binding upon and shall inure to the benefit of the parties and their successors and assigns; however, nothing in this consent shall be interpreted to waive City's right to object to any future transfer or sale of any rights or obligations in this Agreement.
 - 6. This Assignment shall be governed by the laws of the State of California.
 - 7. This Assignment shall be effective upon execution by City.
- 8. This Assignment may be executed in any number of counterparts, and each executed counterpart shall have the same force and effect as an original instrument and shall be construed as if all the parties to the aggregate counterparts had signed the same instrument.
