

1 FIRST AMENDMENT TO AGREEMENT NO. 30933

3 THIS AGREEMENT is made and entered, in duplicate, as of October 15,
4 2009 for reference purposes only, pursuant to a minute order adopted by the City Council
5 of the City of Long Beach at its meeting held on August 5, 2008, by and between
6 ANCHOR ENVIRONMENTAL CA, L.P., a California corporation, with a place of business
7 at 28202 Cabot Road, Suite 425, Laguna Niguel, California 92677 ("Consultant"), and the
8 CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with As-Needed Multi-Discipline Coastal Engineering and
11 Environmental Consulting Services ("Project"); and

12 WHEREAS, City selected Consultant in accordance with City's
13 administrative procedures and City has ascertained that Consultant and its employees
14 are qualified, licensed, if so required, and experienced in performing such specialized
15 services; and

16 WHEREAS, the parties entered into Agreement No. 30933 on October 17,
17 2008 for a term of one (1) year; and

18 WHEREAS, the parties now desire to extend the term for an additional
19 year;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
21 conditions in this Agreement, the parties agree as follows:

22 1. Section 2 of Agreement No. 30933 is hereby deleted in its entirety
23 and amended to read as follows:

24 "2. TERM. The term of this Agreement shall commence on
25 October 1, 2008, and shall terminate on September 30, 2010, unless sooner terminated
26 as provided in this Agreement, or unless the services or the Project is completed sooner."

27 2. Except as set forth in this First Amendment to Agreement No. 30933,
28 all terms and conditions of the Agreement are ratified and confirmed and shall remain in
