

1 FIRST AMENDMENT TO AGREEMENT NO. 34487

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34487 is made and  
4 entered, in duplicate, as of August 8, 2019, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 December 20, 2016, by and between RMA GROUP, a California corporation  
7 ("Consultant"), with a place of business at 1210 E. 223rd Street, Suite 319, Carson,  
8 California 90745, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
10 34487 (the "Agreement") whereby Consultant agreed to provide as-needed construction  
11 materials testing and inspection services; and

12 WHEREAS, the Parties desire to add \$2,000,000 for a total not to exceed  
13 amount of \$4,000,000 and extend the term one (1) additional one-year period;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows:

17 "A. Consultant shall furnish specialized services more particularly  
18 described in Exhibit "A", attached to this Agreement and incorporated by this  
19 reference, in accordance with the standards of the profession, and City shall pay for  
20 these services in the manner described below, not to exceed Four Million Dollars  
21 (\$4,000,000), at the rates or charges shown in Exhibit "B".

22 2. Section 2 of the Agreement is hereby amended to read as follows:

23 "2. TERM. The term of this Agreement shall commence at midnight on  
24 January 1, 2017, and shall terminate at 11:59 p.m. on December 31, 2020, unless sooner  
25 terminated as provided in this Agreement, or unless the services or the Project is  
26 completed sooner. The Parties have the option to extend the term one (1) additional one-  
27 year period at the discretion of the City Manager."

28 3. Except as expressly amended herein, all terms and conditions in
