COMMUNICATION REGARDING SELECTIONS FROM REFUSE FIELD INVESTIGATOR ELIGIBLE LIST:

Pearson, Refuse Operator, regarding his exclusion from being selected from the Refuse Field Investigator eligible list. Mr. Pearson addressed the Commission, stating his concerns that he had been interviewed three times for the position of Refuse Field Investigator and has never been selected nor had any feedback as to why he was not selected. He also indicated that he felt that he was being discriminated against because he is a Union Steward. He requested the Commission investigate the interview process to determine what, if any, inconsistencies there were in the interview process. He also informed the Commission that he had not received a Performance Appraisal Review in three years. Cynthia Stafford. Personnel Services Officer, Public Works, informed the Commission that the department has a selection process that has not been concluded, and that she did not feel comfortable discussing the matter at this time in open session. Commissioner Hicks stated that if there is a process currently in place, it would be premature for the Commission to make a decision. Commissioner Good questioned as to how often an employee is to receive a Performance Appraisal Review. He requested Ms. Stafford report back to the Commission the reason Mr. Pearson had not received a Performance Appraisal Review in three years. Christina Checel, Deputy City Attorney and Commission Advisor, informed the Commission that many of the issues Mr. Pearson raises, although valid issues, are outside the jurisdiction of the Commission. She also informed the Commission that any issue regarding potential union retaliation has not business before the Commission. She also stated that department selection is contained within the department and any investigation by the Commission would no be appropriate and non-career employment is also outside the jurisdiction of the Commission. Regarding Mr. Pearson's communication to the Commission being posted, she stated that because Commission agendas are available to the public, there is no violation. Commissioner Good stated that he would like to know when the communication from Mr. Pearson was posted on his department's board. Commissioner Smith Watts indicated to Ken Walker, Manager, Personnel Operations, Human Resources that maybe some type of

communication regarding the process and why they were not selected for a position be available to employees. Mr. Walker informed the Commission that Human Resources would pursue Mr. Pearson's allegation of union animosity. He stated that once the selection process is completed, Human Resources will pursue the allegation. He stated that once the process is completed, he is sure Public Works will give Mr. Pearson feedback regarding his interview. Commissioner Hicks stated that his concern is that Mr. Pearson indicated that this is the third time and he has not received feedback from the previous two times. Chris Ward, Union Representative, stated that he felt this was in the jurisdiction of the Commission. Commissioner Good informed Mr. Ward that since it has been determined that this matter is outside of the Commission's jurisdiction. there is no need for further comments. After discussion, it was moved by Commissioner Hicks, seconded by Commissioner Good and carried to receive and file Mr. Pearson's communication. The motion carried by a unanimous roll call vote.



SUSPENSION APPEAL 26-S-910

The Secretary presented a communication from Patrick H.
