WHEREAS, pursuant to the Agreement, City has granted to Licensee a nonexclusive revocable license to use the area of City Property for the purpose of conducting a certified farmer's market; and

WHEREAS, City and Licensee desire to amend License Agreement No. 32338 by extending the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in License Agreement No. 32338, City and Licensee agree as follows:

- 1. Section 3 of License Agreement No. 32338 is hereby amended in its entirety to read as follows:
- "3. <u>TERM.</u> The initial term of this License Agreement shall commence on January 1, 2011 and shall terminate on December 31, 2014. The first extended term of this License Agreement shall commence on January 1, 2015 and shall terminate on December 31, 2015. The second extended term of the License Agreement shall commence on January 1, 2016 and shall terminate on December 31, 2016. The License Agreement may be terminated by either party, at any time, with thirty (30) days' written notice."
