6	BOLDER GROUP, INC. DBA ALAMITOS BAY MARINE ("Contractor"), a California
7	corporation, located at 227 Marina Drive, Long Beach, California 90803 and the CITY OF
8	LONG BEACH ("City"), a municipal corporation.
9	WHEREAS, City did by Resolution No. RES-08-0036 determine that the
10	City's need to purchase marine fuel and related supplies could only be met by Contractor

13	NOW, THEREFORE, in consideration of the mutual terms and conditions
14	contained herein, the parties agree as follows:
15	1. Contractor shall sell, furnish and deliver to City marine fuel and
16	related supplies as authorized by Resolution No. RES-08-0036.
17	2. City shall pay Contractor in due course of payments for the marine
18	fuel and related supplies a sum not to exceed \$140,000, including tax.
19	3. The term of this Contract shall commence at midnight on July 1,
20	2008, and shall terminate on May 31, 2009.
21	4. Neither this Contract nor any of the moneys that may become due
22	Contractor hereunder may be assigned without the prior written consent of City.
23	5. Any notices required hereunder or desired to be given by either party
24	shall be in writing and personally delivered or deposited in the U.S. Postal Service, first
25	class postage prepaid, addressed to Contractor at the address stated herein, and to City
26	at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager. Notice
26 27	shall be deemed given on the date personal delivery is made or on the date of deposit in
