3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 34132 is made and
4 entered, in duplicate, as of November 4, 2017, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 20, 2015, by and between JOVENVILLE, LLC DBA WE THE CREATIVE, a
7 California limited liability company ("Consultant"), with a place of business at 2810 Villa
8 Way, Newport Beach, California 92663, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed graphic design and creative services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
13 34132 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement to
15 increase the Agreement amount by \$28,500 for a total not to exceed amount of \$38,500;
16 and

17 WHEREAS, the Parties entered into a Second Amendment to the Agreement
18 to increase the Agreement amount by \$57,400 for a total not to exceed amount of \$95,900;
19 and

20 WHEREAS, the Parties entered into a Third Amendment to the Agreement
21 to increase the Agreement amount by \$35,000 for a total not to exceed amount of
22 \$130,900; and

23 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
24 to increase the Agreement amount by \$47,576 for a total not to exceed amount of
25 \$178,476; and

26 WHEREAS, the Parties desire to increase the Agreement amount by
27 \$215,000 for a total not to exceed amount of \$393,476 and extend the term an additional
28 one (1) year period;
