1 FIRST AMENDMENT TO CONTRACT NO. 34196

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34196 ("First Amendment")  
4 is entered into, in duplicate, effective as of June 8, 2016, for reference purposes only,  
5 pursuant to a minute order adopted by the City Council of the City of Long Beach at its  
6 meeting held on November 17, 2015, by and between BLUEDROP LEARNING NETWORK  
7 INC., a for-profit corporation with offices located at 18 Prescott Street, St. John's,  
8 Newfoundland, Canada A1C 3S4 ("Contractor") and the CITY OF LONG BEACH, a  
9 municipal corporation ("City") and administering entity for Pacific Gateway Workforce  
10 Investment Network.

11 WHEREAS, City requires specialized services requiring unique skills to be  
12 performed in providing web-based platform materials to assist dislocated workers in  
13 transitioning their skills; and

14 WHEREAS, the City and Contractor entered Contract No. 34196 (the  
15 "Contract") whereby Contractor agreed to provide such services; and

16 WHEREAS, the City and Contractor desire to extend the term;

17 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
18 the Contract and in this First Amendment, the parties agree as follows:

19 1. Section 2.A of Contract No. 34196 is hereby amended to read as  
20 follows:

21 "2. TERM.

22 A. The term of this Contract shall be deemed to have commenced  
23 as of June 1, 2015, and unless sooner terminated pursuant to the provisions hereof,  
24 shall terminate on December 31, 2017. City shall have the right to terminate this  
25 Contract in its entirety at any time during the Term for any or no reason whatsoever  
26 by giving fifteen (15) days prior written notice of termination to the other party. City  
27 shall have the additional right to cancel any part of this Contract at any time during  
28 the Term for any reason whatsoever by giving fifteen (15) days' notice of such
