## FIRST AMENDMENT TO CONTRACT NO. 34196

THIS FIRST AMENDMENT TO CONTRACT NO. 34196 ("First Amendment") is entered into, in duplicate, effective as of June 8, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 17, 2015, by and between BLUEDROP LEARNING NETWORK INC., a for-profit corporation with offices located at 18 Prescott Street, St. John's, Newfoundland, Canada A1C 3S4 ("Contractor") and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City requires specialized services requiring unique skills to be performed in providing web-based platform materials to assist dislocated workers in transitioning their skills; and

WHEREAS, the City and Contractor entered Contract No. 34196 (the "Contract") whereby Contractor agreed to provide such services; and

WHEREAS, the City and Contractor desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract and in this First Amendment, the parties agree as follows:

1. Section 2.A of Contract No. 34196 is hereby amended to read as follows:

## "2. TERM.

A. The term of this Contract shall be deemed to have commenced as of June 1, 2015, and unless sooner terminated pursuant to the provisions hereof, shall terminate on December 31, 2017. City shall have the right to terminate this Contract in its entirety at any time during the Term for any or no reason whatsoever by giving fifteen (15) days prior written notice of termination to the other party. City shall have the additional right to cancel any part of this Contract at any time during the Term for any reason whatsoever by giving fifteen (15) days' notice of such

## cancellation to the Contractor."

2. Except as expressly amended in this First Amendment, all terms and conditions in Contract No. 34196 are ratified and confirmed and shall remain in full force and effect.
