A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH WESTNET, INC., WITHOUT ADVERTISING FOR BIDS, FOR PURCHASING AND INSTALLING EQUIPMENT TO UPGRADE THE FIRE STATION ALERTING SYSTEM IN AN AMOUNT NOT TO EXCEED \$215,326

WHEREAS, in 2003, Westnet, Inc. ("Westnet") installed the First-In Alerting System in the Fire Communications Center and all City of Long Beach fire stations, and has since provided maintenance and service for this system; and

WHEREAS, the Long Beach Fire Department ("LBFD") has not replaced or upgraded much of the original equipment installed in 2003 and desires to purchase new Alerting Master Control Units to upgrade all fire station alerting system hardware to the most current technology; and

WHEREAS, purchasing new Westnet alerting system hardware will increase dispatching and improve response times to assist first responders in meeting the 60-second turn out time goal established by the National Fire Protection Association; and

WHEREAS, Westnet, Inc. does not use regional distributors and is the sole manufacturer and source for their products and as a result, no useful purpose would be served by advertising for bids for furnishing and delivering the alerting system equipment and hardware and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Manager is hereby authorized to enter a contract,

without advertisin	g for bids, with Westne	t, Inc. for the purchase and installation of hardware
