Mayor Foster:

I am here tonight to ask the City Council to direct staff to correct a billing error on the above cited parking citation. I am the owner of the vehicle that received the citation, and I am contesting the citation.

However, because I used a return address label with my wife's name on it, the city on Sept. 14 sent a letter to her demanding payment from her. For the record, she is not an owner of the vehicle, has never been an owner of the vehicle, and her name has never appeared on the vehicle's registration. She is no more liable for this citation than you.

My wife has sent a letter to Parking Enforcement demanding that it dismiss any citation that it has issued against her. So far, no response. I have called Parking Enforcement and ask that it send us a letter stating that it would take no further action against my wife. The department sent a letter explaining the citation process, but would not send a letter saying that my wife is not responsible for the citation.

I called the City Attorney's office. In a telephone conversation, Deputy City Attorney Ann Burton explained to me that the city would not send a letter clearing my wife, blamed me for using the return address label upon which the city has billed my wife, and said that the city could not send a letter absolving my wife of liability for the citation because I would then transfer the vehicle title into her name and avoid responsibility for the citation. When I asked her to put her explanation into writing and send it to me, she said, "I will not," and hung up.

Since then, my emails to the City Attorney's office have gone unanswered.

I am asking the city for a letter to Sandra J. Gougis that states that the demand for payment she received on Sept. 14 was issued in error and that she may disregard that letter.

Thank you for your attention to this matter.

Ms. Burton:

I am sorry that you have declined to put into writing the contents of our telephone conversation of Monday, Sept. 27, at 3:22 Pacific Time. This email will serve to memorialize the conversation's most significant points.

#### You stated:

- The city did, indeed, send a letter to Sandy Gougis, my wife, in regards to a parking citation on a vehicle she does not own.
- The letter was generated because of a return address label on a letter sent to the city.
- While Sandy Gougis is not a registered owner of the vehicle, the city will not write a letter stating that Sandy Gougis was sent a demand for payment in error, nor will the city write a letter stating that Sandy Gougis is not liable for a parking citation on a vehicle she does not own.

This is because, as you explained, the citation goes with the vehicle, the vehicle's title could - at some unspecified point in the future - be transferred to her, and the city cannot release Sandy Gougis from future liability in case at some point in the future she does become the legal owner of the vehicle and the ticket remains unpaid.

- When I asked you to place your explanation in writing, your response was, "I will not," and abruptly terminated the call at 7 minutes exactly.

If any of these statements are incorrect, please feel free to correct them via email to me.

I will continue to try to clear my wife's name from this increasingly Kafka-esque situation. I have written the City Attorney's office again asking for a letter clearing my wife of liability for this citation or an explanation of why it will not issue a letter stating that my wife's name was attached to this citation in error. This time, I have asked for either the letter or the explanation to be delivered to me in writing.

While I have asked Executive Assistant Karen Hester for such a letter or written explanation as to why one is not forthcoming, I would appreciate receiving said letter or written explanation of the denial of my request from either Mr. Shannon or Ms. Burton.

Thank you for your attention to this matter. I truly do not understand why it is so difficult for the city to undo a simple error.
