5 HEARING, THE RENAMING THE EAST ANAHEIM STREET
6 PARKING AND BUSINESS IMPROVEMENT AREA TO THE
7 ZAFERIA PARKING AND BUSINESS IMPROVEMENT AREA

9 WHEREAS, on January 7, 2020 at 5:00 p.m., the City Council conducted a
10 public hearing relating to renaming the East Anaheim Street Parking and Business
11 Improvement Area to the Zaferia Parking and Business Improvement Area in accordance
12 with its Resolution of Intention No. RES-19-0196, adopted December 17, 2019, at which
13 public hearing all interested persons were afforded a full opportunity to appear and be
14 heard on all matters relating to the Report; and

15 WHEREAS, a majority protest not having been received, it is the City
16 Council's desire to rename the East Anaheim Street Parking and Business Improvement
17 Area to the Zaferia Parking and Business Improvement Area;

18 NOW THEREFORE, the City Council of the City of Long Beach resolves as
19 follows:

20 Section 1. A public hearing having been conducted on January 7, 2020,
21 at 5:00 p.m., and all persons having been afforded an opportunity to appear and be
22 heard, the City Council hereby renames the East Anaheim Street Parking and Business
23 Improvement Area to the Zaferia Parking and Business Improvement Area as approved
24 by Resolution No. RES-19-0196, adopted December 17, 2019.

25 Section 2. This resolution shall take effect immediately upon its adoption
26 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
