RECOMMENDATION:

- 1) Adopt Plans and Specifications No. R-6797 for the rehabilitation of Harding Street between Deforest Avenue and Atlantic Avenue, and authorize the City Manager to award and execute the contract with Silvia Construction, Inc., in an estimated amount of \$190,243 plus a 10 percent contingency amount of \$19,024, if necessary, for a total of \$209,267, and any amendments thereto except for an increase in the contract price.
- 2) Increase appropriations by \$237,804 in the Gas Tax Street Improvement Fund (SR 181) in the Department of Public Works (PW) for construction and construction inspection costs related to this project. Funding for this project is from the American Recovery and Reinvestment Act of 2009 (ARRA). (District 9)

DISCUSSION

As part of the American Recovery and Reinvestment Act of 2009 (ARRA), certain funds were set aside for the rehabilitation of roads. Projects to be done under this program had to be ready to go to construction immediately, listed as a federal aide urban route (FAU) by the Federal Highway Administration, and listed in the State's Transportation Improvement Program. Harding Street between Deforest Avenue and Atlantic Avenue fell into this category and was approved for funding under this ARRA program.

The anticipated rehabilitation work on Harding Street will consist of removing concrete and bituminous surfaces; constructing Portland cement concrete curbs, gutters and sidewalks; doing all necessary excavation and grading; cold milling; constructing asphalt concrete pavement on aggregate base and resurfacing with rubberized asphalt pavement; and furnishing and installing pavement markers, markings and traffic striping. A vicinity map of the area is attached as Exhibit A.

City Council's adoption of the plans and specifications and award of the contract to the lowest responsible bidder are being recommended concurrently in order to expedite implementation of this project. The project was advertised for bids on July 24, 2009, and bids were opened on August 27, 2009. Information regarding Silvia Construction is provided on the attached contract award document marked as Exhibit B.

This matter was reviewed by Deputy City Attorney Linda Trang on September 15, 2009 and by Budget and Performance Management Bureau Manager David Wodynski on September 21, 2009.

SUSTAINABILITY

The street will be resurfaced with asphalt containing up to 15 percent recycled material as well as recycled rubber from old tires. It is estimated that up to 1,720 tires will be recycled through the use of rubberized asphalt in this project.

TIMING CONSIDERATIONS

City Council action on this matter is requested on October 6, 2009, to authorize commencement of this Public Works project. Construction is projected to begin in January 2010, and should take approximately 50 working days.


FISCAL IMPACT

The contract award is for an estimated amount of \$190,243, plus a 10 percent contingency of \$19,024, if necessary and if funds are available, and a 15 percent estimate for construction support including such work activities as inspection, material testing and DBE and prevailing wage oversight, in the amount of \$28,536. Since this federal stimulus grant funding is not yet appropriated, an appropriation increase of \$237,804 is requested in the Gas Tax Street Improvement Fund (SR 181) in the Department of Public Works (PW).

SUGGESTED ACTION:

Approve recommendation.

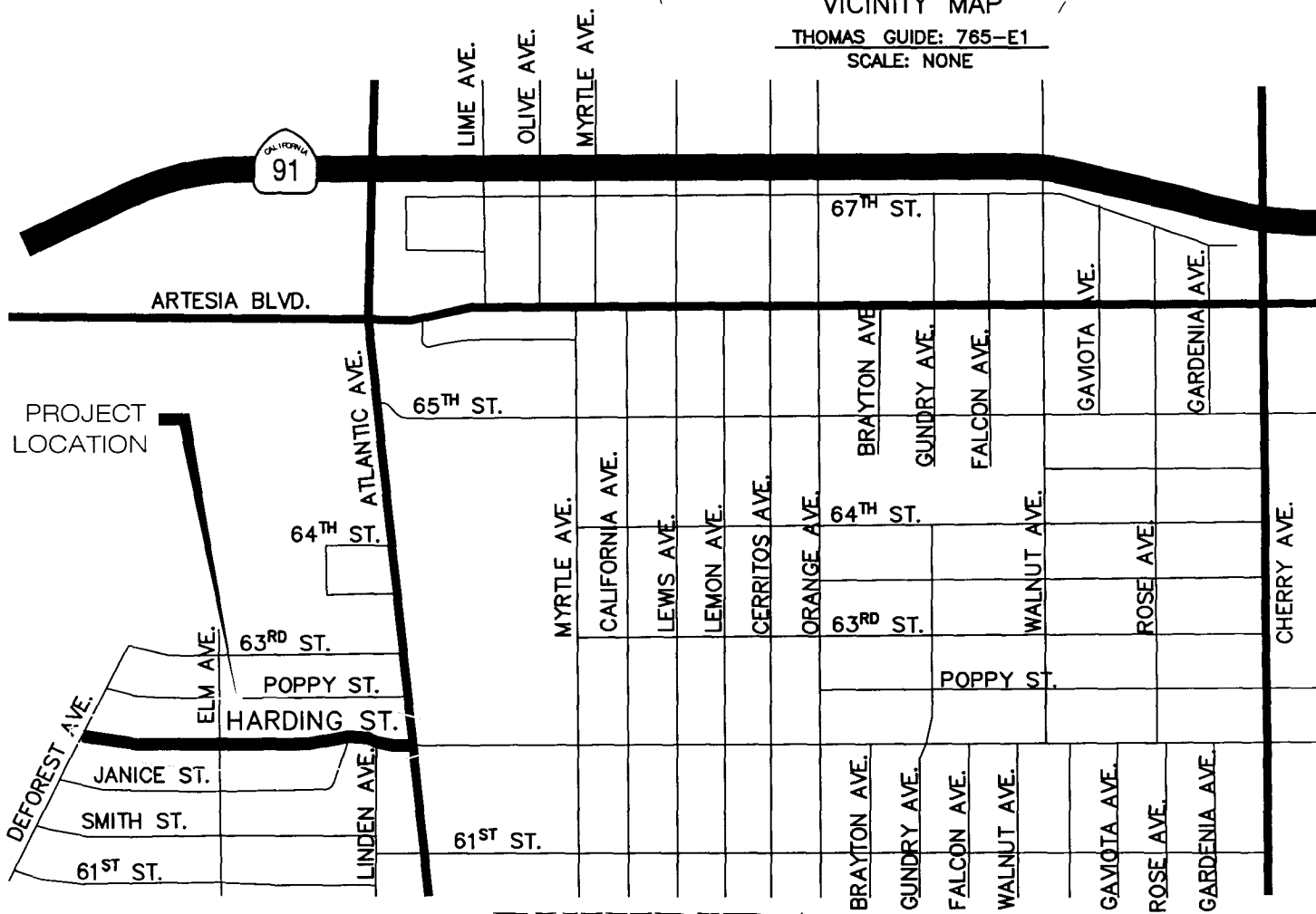

There were twenty-five (25) Plans and Specifications sold. Twelve (12) bids were received, one (1) from a local firm, one (1) from a WBEs and one (1) from a MBE. None were received from DBEs.

Linda Trang, Deputy City Attorney, approved the Plans and Specifications on July 13, 2009.

The above is a construction project, which can be increased up to 25% above the award amount with no further City Council Actions, per the standard Specifications for Public Works Construction ("Green Book") which has been adopted by the City Council.

PROCUREMENT OUTREACH: Advertisements are placed in the Press – Telegram. In a continuing effort to increase participation of Long Beach businesses, MBEs and WBEs, bids for construction projects exceeding \$100,000 are sent, by the Public Works Department, to approximately 20 trade publications and plan rooms catering to the construction industry.
