Higuera Street, Suite 102, San Luis Obispo, California 93401, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with on-call planning consulting services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33777 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the total not to exceed Agreement amount to \$450,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the total not to exceed Agreement amount to \$900,000 and extend the term; and

WHEREAS, the Parties desire to extend the term an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on January 1, 2015, and shall terminate at 11:59 p.m. on December 31, 2018, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
 - 2. Except as expressly modified herein, all of the terms and conditions
