3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE AN AGREEMENT WITH
6 ARCHI.TXTURE, LLC DBA CATALYST OFFICE FOR THE
7 PURCHASE AND DELIVERY OF FURNITURE WITH
8 RELATED ACCESSORIES AND SERVICES, THROUGH
9 THE NATIONAL JOINT POWERS ALLIANCE (NJPA)
10

11 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
12 1802, permits the City to purchase services, supplies, materials, equipment and labor
13 with other government agencies by purchasing under their contracts on a voluntary and
14 selective basis when authorized by resolution; and

15 WHEREAS, the City desires to purchase furniture with related accessories
16 and services to furnish four (4) floors of office space located at the Long Beach Airport;
17 and

18 WHEREAS, Steelcase, Inc. sells its products through authorized Steelcase
19 dealers that are independently owned and operated; and

20 WHEREAS, Archi.Txture, LLC dba Catalyst Office is an authorized dealer
21 for Steelcase, Inc.; and

22 WHEREAS, the National Joint Powers Alliance (NJPA) has a contract for
23 the procurement of furniture with related accessories and services under Contract No.
24 031715-STI ("NJPA Contract"); and

25 WHEREAS, the City's participation in the NJPA Contract will facilitate timely
26 acquisition of the furniture with related accessories and services as well as provide
27 considerable cost benefits to the City; and

28 WHEREAS, if the City had to utilize a formal bid process rather than

1 participate in the NJPA Contract considerably more funds would be required;

2 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
3 follows:

4 Section 1. The above recitals are true and correct and are incorporated
5 herein by this reference.

6 Section 2. The City Manager of the City is hereby authorized to enter an
7 agreement with Archi.Txture, LLC dba Catalyst Office to purchase furniture with related
8 accessories and services, of the same type and kind identified in the NJPA Contract
9 except as modified by mutual agreement of the City and Archi.Txture , LLC dba Catalyst
10 Office, in an amount not to exceed Three Hundred Fifty Thousand Dollars (\$350,000),
11 including tax, on the same terms and conditions as the NJPA Contract.

12 Section 3. This resolution shall take effect immediately upon its adoption
13 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

14 I hereby certify that the foregoing resolution was adopted by the City
