SEVENTH AMENDMENT TO AGREEMENT NO. 34492

THIS SEVENTH AMENDMENT TO AGREEMENT NO. 34492 is made and entered, as of October 14, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 11, 2022, by and between GROUP DELTA CONSULTANTS, INC., a California corporation ("Consultant"), with a place of business at 370 Amapola Avenue, Suite 212, Torrance, California 90501, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34492 (the "Agreement") whereby Consultant agreed to provide as-needed construction materials testing and inspection services in an amount not to exceed One Million Dollars (\$1,000,000) for a period of three (3) years, with the option to renew for two (2) additional one-year periods, at the discretion of the City Manager; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add Two Million Dollars (\$2,000,000) for a total not to exceed amount of Three Million Dollars (\$3,000,000); and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add One Million Dollars (\$1,000,000) for a total not to exceed amount of Four Million Dollars (\$4,000,000), extend the term to December 31, 2020, and attach an updated rate sheet; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to update the rate sheet; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to December 31, 2021; and

WHEREAS, on August 3, 2021, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to extend the term to December 31, 2022; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to add One Million Three Hundred Thousand Dollars (\$1,300,000) for a total not to exceed amount of Five Million Three Hundred Thousand Dollars (\$5,300,000); and

WHEREAS, on October 11, 2022, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties desire to add One Million Five Hundred Thousand Dollars (\$1,500,000) to the Agreement for a total not to exceed amount of Six Million Eight Hundred Thousand Dollars (\$6,800,000), extend the term one (1) additional one-year period, and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Six Million Eight Hundred Thousand Dollars (\$6,800,000), at the rates or charges shown in Exhibit "B-3"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. TERM. The term of this Agreement shall commence at midnight on January 1, 2017, and shall terminate at 11:59 p.m. on December 31, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- The Rates in Exhibit "B-2" to the Third Amendment to the Agreement 3. are hereby amended in accordance with Exhibit "B-3", attached hereto and incorporated by this reference."
- Except as expressly amended herein, all terms and conditions in Agreement No. 34492 are ratified and confirmed and shall remain in full force and effect.
