1 FIFTH AMENDMENT TO AGREEMENT NO. 33914

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 33914 is made and
4 entered, in duplicate, as of June 9, 2021 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on June 8, 2021,
6 by and between GWYNNE PUGH URBAN STUDIO INC., a California corporation
7 ("Consultant"), with a place of business at 2800 28th Street, Suite 171, Santa Monica,
8 California 90405, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 33914 (the "Agreement") whereby Consultant agreed to provide as-needed architectural
11 services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 add \$100,000 for a total not to exceed amount of \$600,000 and extend the term to July 19,
14 2018; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to extend the term to July 19, 2019; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement
18 to extend the term to July 19, 2020; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to extend the term to July 19, 2021; and

21 WHEREAS, the Parties desire to extend the term one (1) additional one-year
22 period;

23 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
24 conditions herein contained, the Parties agree as follows:

- 25 1. Section 2 of the Agreement is hereby amended to read as follows:
- 26 "2. TERM. The term of this Agreement shall commence at midnight on
27 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2022 unless sooner terminated
28 as provided in this Agreement, or unless the services or the Project is completed sooner."
