Thank you for this opportunity to voice my comments about the applications for entertainment with dancing by patrons permits at both of these venues.

As a property owner at The Lafayette, I am deeply disturbed by the activities that transpire at Broadlind Lounge, aka The Basement.

Patrons entering and exiting these premises are rude, inflict damage to vehicles in the area and, quite frankly, this type of venue is not what we want in the East Village Art District. In lieu of granting a permit to The Basement, please do the right thing and shut this place down. Permanently.

Lest you think I'm a NIMBY, I have been to this venue once and stayed less than half an hour, realizing quickly the clientele was obnoxious and disrespectful of everyone in the neighborhood.

Please shut down the Broadlind Lounge, aka The Basement now.

As for Bliss 525, the clientele is a step up from The Basement but still quite loud - and I am profoundly hard of hearing. My condominium is in the Campbell building facing Bliss 525 and, with windows open, often the music seems to be directly in my living room.

Despite this, I've found the Bliss 525 patrons to be civil, respectful of the neighborhood and I see no reason to deny them the permit they request.
