#### **RECOMMENDATION:**

Adopt the attached resolution and authorize the City Manager to execute all necessary documents to receive and expend grant funding from the State of California Department of Alcoholic Beverage Control 2012 grant, and increase appropriations in the General Grants Fund (SR 120) in the Police Department (PD) by \$45,000. (Citywide)

#### **DISCUSSION**

On June 1, 2012, the Long Beach Police Department was awarded grant funding from the State of California Department of Alcoholic Beverage Control 2012 (ABC 12) grant in the amount of \$45,000. The grant monies will be used for overtime, investigative services, and training to identify and focus on problematic ABC licensed establishments, and to ensure compliance with City and State laws to improve public safety and solve neighborhood problems.

This matter was reviewed by Deputy City Attorney Gary Anderson on July 2, 2012 and Budget Management Officer Victoria Bell on June 29, 2012.

#### TIMING CONSIDERATIONS

City Council action on this matter is requested on July 10, 2012, to expedite use of the grant funds.

#### FISCAL IMPACT

As the ABC 12 grant is currently unbudgeted, an appropriation increase in the General Grants Fund (SR 120) in the Police Department (PD) in the amount of \$45,000 is included in the recommendation. Grant revenues will offset the expense appropriation and the grant does not require matching funds. There is no impact to the General Fund and no local job impact associated with the recommended action.

Section 2. IT IS AGREED that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and ABC disclaim responsibility for any such liability.

Section 3. BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

Section 4. IT IS ALSO AGREED that this award is not subject to local hiring freezes.

Section 5. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
