1 FIRST AMENDMENT TO AGREEMENT NO. 32308

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32308 is made and
4 entered, in duplicate, as of November 20, 2013 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 July 5, 2011, by and between WESTGROUP DESIGNS, INC., a California corporation,
7 with a place of business at 19520 Jamboree Road, Suite 100, Irvine, California 92612
8 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with space planning consulting services; and

11 WHEREAS, the parties entered Agreement No. 32308 whereby Consultant
12 agreed to provide these services; and

13 WHEREAS, the parties desire to decrease the Agreement amount by
14 \$50,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 1.A. of Agreement No. 32308 is hereby amended to read as
18 follows:

19 "1. SCOPE OF WORK OR SERVICES.

20 A. Consultant shall furnish specialized services more particularly
21 described in Exhibit "A", attached to this Agreement and incorporated by this
22 reference, in accordance with the standards of the profession, and City shall pay
23 for these services in the manner described below, not to exceed Fifty Thousand
24 Dollars (\$50,000), at the rates or charges shown in Exhibit "B".


25 2. Except as expressly modified herein, all of the terms and conditions


